To take advantage of a host of business benefits and to stay in compliance, it is important that you register your industrial establishment in the Industrial Register with Industry Affairs at the Ministry of Industry and Commerce (MOIC). To register, simply follow the steps below.

### **REQUIRED STEPS**

In order to start the industrial registration application, you would need to activate the eKey for employer/owner ID card.

# APPLY FOR A DUTY EXEMPTION





Your business can thrive with exemptions on duties that you can apply for via the Industrial Services System, a web platform controlled by Industry Affairs at the Ministry of Industry and Commerce (MOIC).

# REQUIRED DOCUMENTS



Copy of audited report for the consumed spare parts & raw material from an external local firm (only in case if duty exemption for spare parts is required)



Copy of audited report for the consumed raw materials\* from an external audit firm (\*if required, only for certain raw materials)



Machinery and equipment catalogue and pictures



Product's HS Code List



Contact details of the company's authorised individual

# **REQUIRED STEPS**





Activate eKey for employer's or owner's ID card.

STEP 02



Login to the Industrial Affairs Online Service either 4 months before the arrival of the shipment or 4 months before the expiry of existing exemptions





Fill in and submit the requested information





Industrial Development Directorate will verify the application and will send an initial deposit guarantee letter based on applicant request

\$TEP 05



Deposit the Bank Guarantee (5% of the shipment)





Submit the clearance documents to Customs and clear the shipment





Cabinet of Ministers will issue the resolution of exemption to approve for exemption



Resolution is circulated to Customs Affairs for implementation





You, the applicant, will receive the exemption and can collect your deposit back
