Setting up in Business Friendly Bahrain is simple and straightforward. Get up and running with the steps below to take advantage of a world of opportunities that the Kingdom has to offer.

Stage 1: CR without license

1 SELECT A SERVICE PROVIDER



A service provider will guide you through the registration process. Please consult [this list](#) for provider options.

2 CHOOSE YOUR TYPE OF BUSINESS



A Select your business activity on [Sijilat](#)

Each business activity has corresponding conditions, terms, and documents that must be fulfilled.



B Decide on your legal structure

- Company with Limited Liability (WLL)
- Shareholding Company (BSC)
- Foreign Branch
- Other structures also available

3 RESERVE YOUR COMMERCIAL NAME



Choose a name in both English and Arabic for approval with [Sijilat](#)

4 PREPARE YOUR DOCUMENTS

Compile your documents.

- A** Authenticate them using one of the methods below:
- Apostilling, for countries that have signed the treaty drafted at the Hague Conference on Private International Law.
 - Regular authentication, for all other countries not under said treaty.
- B** Notarise your documents with a public or [private notary](#).



WLL, BSC, AND FOREIGN BRANCHES

- Board or Shareholder Resolution (notarisation required)
- Parent company CR (authentication required)
- Parent Company Memorandum of Association or Articles of Association (authentication required)



WLL

- Power of attorney (POA)
- Passport copy of shareholder

* Individual establishments will only require a passport copy, unless given POA to others.



BSC & BSC CLOSED

- Appointment of Compliance Officer



FOR FOREIGN BRANCHES

- Parent company audited financial report



FOR ALL COMPANIES

- Disclosure of Ultimate Beneficiary

5 SUBMIT YOUR APPLICATION



Complete the steps below to receive a CR without a license.

- Authenticate the necessary documents
- Submit your documents to Ministry of Industry and Commerce via [Sijilat](#)
- Your application will be processed with a security clearance and verification of commercial name
- Your CR without license would be issued

Stage 2: CR with license “Get license”

6 SELECT YOUR BUSINESS LOCATION

7 OBTAIN YOUR LICENSED COMMERCIAL REGISTRATION (CR)



To receive a license for your business, follow the next steps.

- Obtain municipal approvals
- Obtain relevant approvals and licenses from related entities
- Sign Articles/Memorandum of Association in the public notary (If required)
- Open a bank account and deposit your capital (If required)

8 START YOUR OPERATIONS



Begin your administrative procedures to start running.

 - Register your employees individually
 - Increase your employment ceiling
